3. Report of the Chairperson

a. Draft NCLF Strategic Plan – 2020-2022

The feedback will then be compiled, and the document amended as necessary. It will be sent out prior to a videoconference board meeting to be held approximately 35 days from today's meeting.

4. Financial Report

a. 2019 Year-to-Date Financial Statements/Draft Budget 2020

The federation manager provided an overview of the Budget-to-Actuals to the end of August 2019 and walked the Board through the draft 2020 Budget. She noted that the Librarians Advisory Group would be reviewing the budget draft at its meeting on October 21.

The Chairperson asked that board members review the document and provide any feedback to the manager prior to the videoconference meeting. That will be added to the feedback from the Librarians Advisory Group and a final draft will be circulated along with the final draft of the Strategic Plan for 2020-2022. The Board will vote on both final drafts at its meeting in November.

5. Manager's Activity Report

The Manager reviewed her activity report for the period June through September 2019. There was a discussion regarding the manager assuming the bookkeeping duties effective November 1. The Chairperson noted that the Chairperson, Vice-Chairperson and Treasurer had met with the manager prior to the board

meeting to discuss this and the possible impact it might have on her other federation responsibilities. It had been agreed that there would be a review, prior to the next NCLF Board meeting, to evaluate how things had gone.

8. Around the Federation – Updates and Events of Note from Member Libraries
