c. Provincial Enhancement Grant and 3-Year Operational Funding

Thom Knutson outlined the details of the Enhancement Grant and 3-Year Funding Grant received by the NCLF from the Public Libraries Branch, Ministry of Municipal Affairs. Thom noted that the federations are seeking clarity on the annual operating grant at the end of the 3-year funding.

d. BCLTA Emergency Preparedness Presentation

The BCLTA is developing an emergency preparedness resource for public library boards. As the developers of the resource were unavailable, Thom Knutson presented the details, including information on a survey and upcoming focus groups.

APPENDIX A – AROUND THE FEDERATION

Valemount

Covid grant being spent in conjunction with Columbia Basin Trust funds on new HVAC, new roof, new checkout counter; \$5000 from Ledcor being used to install gazebo in front of library; first new staff hire in 15 years; 2 new trustees (have served previously).

Burns Lake

Municipal centennial celebration: August parade, vendors, etc.; not sure of library involvement yet; new staff; 3 new trustees; high staff turnover.

Cariboo

Using Covid grant on connectivity (2 Starlink dishes for community branches), and accessibility (fixing issues like steps); brainstorming ideas for enhancement grant (10-12% allocated to replacing all public computers, \$60,000).

Fraser Lake

Audrey thanked everyone as she retires, warm welcome; seed library up and running, getting planter boxes installed out front and picnic table public using internet after hours, planning for SRC, partnership with museums, sturgeon program, SRC summer student.

Fort St James

Maxime highlighted the work Val is doing, very impressed; budget – got significant increase from district of FSJ; ratified 2nd CUPE agreement, staff earning wage equity with district staff; learning curve for Val; new program – Northern Health alternating Thursdays (mental health, etc.); creating a more private space for outreach programs, working towards a multi-purpose room; Covid funds invested in GIC.

Granisle

Covid projects – OverDrive, directory of services & local volunteer groups (digital and print), STEAM kits; Enhancement grant to help with staffing (Lisa currently working alone).

McBride

Seedy Saturday, outdoor play area very popular; Dome Creek reading room; paramedic on site Wednesday afternoons to talk to people about their needs; one Tuesday/month - legal questions online for free.

Vanderhoof

Brand new board (all); all staff are under 5 years of service, still lots of learning; Covid grant – filters throughout library to help with heat and smoke days; added windows that open; wipeable furniture; MeeScan self-checkout; haven't done anything with enhancement grant yet.

Prince George

Getting ready for *Beyond Hope* conference; 3 new trustees; March retreat – focus on strategic plan, priorities; increase use – new gaming centre, events, seed library.

Anton Dounts (Cariboo) asked how others were using their Covid grant for emergency preparedness. Valemount put \$3000 in reserve for emergencies; Granisle used theirs for prevention measures: workshop, bookmarks with emergency prep information to go in books being checked out, 'grab and go' kit lists, industrial air cleaner, cases of water for heat days.
